The teachers will share the policy with the families at our Fall Back to School Event and all stakeholders will be held responsible for signing the commitment to excellence. The principal will also meet with new families who are coming from others school and have disciplinary or academic records that may indicate previous difficulties. During the meeting the scholar, family and administration will go through the commitment to excellence and outline expectations for family engagement. Throughout the school year, the school leadership team will reach out to all families but especially families whose engagement is lacking and negatively impacting the scholar, meetings may be scheduled to discuss the importance of family engagement and possible barriers that may be making it difficult for the family. The School Secretary also has casual conversations with families if they are bringing their scholar in late or not following through on their commitments. She has copies of the Family Handbook/Commitment to Excellence and highlights the areas that families need to focus on.

Newsletters; At least monthly, from both classroom teachers and the school leadership team

will provide Monthly newsletters sent home via backpack and posted on social media as well as our school website. The Newsletters will outline upcoming events, exciting news, parent involvement opportunities, and other school specific data.

School wide communication system; Daily Classroom teachers and administrators use this system to push out

notifications to parents. Information includes testing reminders, parent involvement opportunities, and reminders about special events. The school wide Communication system allows

school staff to see which families have viewed every message, allowing school leadership team to provide

personal contact for those who did not view the message and make sure that they receive the information.

Coffee and Conversation

Minimum Twice a Year

Coffee and Conversation may take place after a Friday morning NEST assembly which involves a special student performance. This increases parent attendance, making the C and C more productive. Topics of C and C will include:

opportunities to get involved, how to understand your child's recent assessment data, and what you can do at home to support your child's learning.

At least three times a month, the school leadership team will have specific and individual conversations with parents who have the potential to positively contribute to the school community but are hesitant to get involved. The belief is that a personal invitation often goes a long way.
